ORDER

Government have formatted new guidelines for the issuance of NOC for CBSE/ICSE affiliation of Schools as per G.O. read as 3rd & 4th paper above. As per the reference read as 5th paper above, the Hon'ble High Court of Kerala has directed the Government to consider the application of Sree Vidyadhiraja Seva Mission School, Kudakkachira P.O, Kottayam Dt. for grant of NOC without insisiting on compliance with Clauses (iv) and (xiv) of the Guidelines and to pass appropriate orders within 6 weeks from the date of receipt of a copy of the order subject to further orders to be passed in the Writ Petitions. The application of the school was deferred in view of the common Writ Appeal filed by the Government against the Interim Order dated 20.4.2012 in WP(C) No.32940/2011 and other similar cases. The Hon'ble High Court in its judgment dated 14.9.2012 dismissed the Writ Appeal No.1042/2012 repealing the guidelines in respect of minimum strength of pupils (Clause (xiv)) area of land (Clause (iv)) UID details etc. The application of Sree Vidyadhiraja Seva Mission School, Kudakkachira P.O, Kottayam Dt. is defective due to the following reasons:

Government have examined the matter in detail and are pleased to issue NOC for CBSE affiliation to Sree Vidyadhiraja Seva Mission School, Kudakkachira P.O, Kottayam Dt. subject to the outcome of the SLP to be filed by the Government against the judgment dated 14.09.2012 in WA No.1042/12 and execution of agreement with Government in the prescribed format and also subject to the rectification of the defects notified.

The Interim Order read above is thus complied with.
